

### Objective

Setting admissions standards for all the courses/programmes offered in the institute arethe very important function of the education institutes.

#### **Policy Statement**

- A. KLE's Raja Lakhamagouda Science Institute (Autonomous) Belagavi is committed to the goals of quality, diversity and access in its admissions policies.
- B. Institute will base its admission decisions on the academic quality of the applicants; no one will be denied admission on grounds ofage, color, disability, ethnicity, sex, gender identity, gender expression, genetic information, marital status, national origin, race, religion, sexual orientation, or veteran status.
- C. Institute will base its admission decisions on an overall evaluation of applicants' merits, strengths and weaknesses. The college does not use a rigid set of rules. Admission to the college is at the discretion of the Head of the institute.
- D. Institute follows the guidelines for reservation quota as per the Karnataka Govt. order issued from time to time.
- E. Admission to the College does not guarantee admission to all the courses/programmes. Different courses/programs may have specific prerequisites and/or requirements. Selected programs may also have additional requirements for admission.
- F. College has the right to cancel any courses/programs onto which students have been accepted, in accordance with its rules and regulations.

#### **Admission Committee**


#### ELIGIBILITY FOR ADMISSION

## Eligibility for Admission to B.Sc. Programme

- A candidate who has passed two-year Pre-University (Science) examination of the Karnataka State or any other examination Board considered as equivalent thereto is eligible for admission to I Semester B.Sc. Programme.
- A candidate who has passed the three-year Diploma (10+3) in Electronics and Communication Engineering / Computer Science / Electronics and Telecommunication / Instrumentation or any cognate branch from the Directorate of Technical Education Government of Karnataka are eligible for admission to FirstSemester B.Sc.
- A Candidate who has passed 3 years Diploma in Paramedical course and DMLT conducted by Department of Technical Education, Government of Karnataka is eligible for admission to First Semester B.Sc.

## Eligibility for Admission to B.C.A. Programme

 A candidate completing PUC (Science/Commerce) or three years Diploma in engineering by Govt. of Karnataka or any other examination considered as its equivalent is eligible for admission to I Semester B.C.A. Programme.

Eligibility for admission to Post Graduate programme

- Admission to Master of Science Course shall be open for all the candidates who havepassed a Bachelor's Degree examination with not less than 50% of marks in the aggregate of all the years of the Degree examinations. However, in the case of candidate belonging to SC/ST and Cat-I, the aggregate percentage of marks in the qualifying examinations shall not be less than 45%.
- However, he/she shall have studied the concerned PG subject as one of the subjectsat degree level.

A candidate may be refused admission if he/she is found to have indulged in antisocial activities, debarred from other institutions and unlawful demonstrations. If such students are found after admission they may be expelled.

#### Intake


The intake for each Programme and Course is as per the approved capacity from the RaniChannamma University, Belagavi. Any changes in the approved capacity for each Programme and Course will be as per the norms and guidelines from the Government of Karnataka and Rani Channamma University, Belagavi.

#### Admission

The admission to all the Courses/Programmes at Raja Lakhamagouda Science Institute (Autonomous) Belagavi shall be as per the guidelines issued by the Department of Collegiate Education, Government of Karnataka and the guidelines of the Autonomous colleges.

#### Medium of instruction

The medium of instruction and Examination is in English. This is not applicable to language papers.

### a) Application Form

The Application form is a document submitted by an eligible candidate through offline/online seeking admission to available courses/programs in the college. A candidate shall apply a separate application for each courses/programs through offline/online (UUCMS Portal). He/ She shall submit hard copy of the filled Application form along with the relevant documents (wherever is applicable) like Marks Cards, Caste Certificate, Study Certificate, Income Certificate, Migration Certificate and any such documents duly attested by a competent authority/self-attested to the Admission Committee of the college either in person or by post within the last date for submission of application. The college is not responsible for postal delay.

### b) Scrutiny & Verification Process

Admission committee will verify the photocopied & original documents for validating documents submitted by the candidate along with the Application Form for candidate's claims. Candidate's claims are honored if documents are found correct and in order. The application form is liable for rejection without any notice in case of incomplete details or if the attached documents not found to be in order or not valid as per UGC/University Rules.

#### d) Counseling

Admission committee itself acts as a "Counseling Centre" where the candidate is present in person on the day of counseling. The candidate is given an option to choose a particular course/program among the unfilled/available seats as per the guidelines. There will be UUCMS co-coordinator to assist student admission process through UUCMS portal.

#### e) Payment of Fees

At the time of admission, the candidate shall pay the Annual Course/Programme Fee along with other fees for the first year (as already notified by the college). Admission fee shall be paid through bank challan/on-line on the day of Counseling or on the day of confirmation of admission by Committee or else the seat will be cancelled.

### f) Confirmation of Admission

The admission is confirmed once Admission committee receives the office copy of bank challan/NEFT certificate for successful payment by the candidate.

## g) Refund and forfeiture of fees

Candidate who has selected a seat and wish to discontinue for any reason, may cancel his/her seat by submitting the following documents within ten days from the date of admission to get a refund of applicable fee amount. After ten working days of admission no requests for refund will be entertained.

The following documents should be produced for the same:

- · Original Provisional Admission Card
- Original Fee Receipt
- Application for cancellation of seat and refund of fee paid with clear & complete correspondence address.

On receipt of all the above documents, only the tuition fee paid will be refunded and theother fees will be forfeited.

## Change of course/programme

The candidate who has selected a course/programme and also paid the admission fees to the college and later wish to switch over to other course/ programme, such candidate shall pay Rs.1000/- towards processing fee for each change.

After the last date and time fixed by the College & Parent University for admission to the various courses/programmes, the admission shall be closed and under no circumstance's admission shall be done after the last date.

Once the admission process is complete, the list of successfully enrolled students will besent to the parent University for the Approval.

#### Transfer of admission

Transfer of admissions is permissible only for the students of III and V semesters subjected to following conditions;

## Transfer of Students within the University

- His/her transfer admission shall be within the intake permitted to the college
- Availability of same combination of subjects studied in the previous college
- He/she shall fulfill the attendance requirements as per the Regulation
- He/she shall complete the programme as per the regulation governing the maximum duration of completing the programme.

#### Transfer of Students of other Universities

- A Candidate migrating from any other University may be permitted to join III/V
  semester of the degree programme provided he/she has passed all the subjects
  of previous semesters / years as the case may be. Such candidates must satisfy
  all other conditions of eligibility stipulated in the regulations of college and
  parent university Rani Channamma University, Belagavi.
- His / Her transfer admission shall be within the intake permitted to the college
- He/she shall fulfill the attendance requirements as per the University Regulation
- The candidate who is migrating from other Universities is eligible for overall classand not for ranking
- He / She shall complete the programme as per the regulation governing the maximum duration of completing the programme as per this regulation

### **Multiple Entry & Exit**

As per the NEP guidelines student can exercise the option of multiple entry and exit. Depending upon the credits earned at the time of exit the students are eligible for the award of equivalent certificate / Diploma / Degree.

#### Lateral Entry

As per the guidelines of Karnataka State Higher Education Council (KSHEC), Department of Collegiate Education (DCE) and Rani Channamma University, Belagavi, lateral entry for UG programmes (B. Sc & BCA) is permitted.

#### Other Instructions

The information given here is general information for the students. The relevant rules relating to admission, fees and other details will be as and when notified.

All admissions made are provisional. The College/University reserves the right to approve or cancel the admission.
