1. SERVICE DETAILS:

2. Zeel Code Labs-OBLIGATION:

2. INSTITUTION'S OBLIGATION:

- To provide a coordinator and system administrator during the period of internship.
- To provide Logistical support.

3. TERMINATION

Not with standing any provision of this Agreement to the contrary, to the extent not prohibited by applicable law, either Party may, in its sole discretion, which may be exercised for any reason or for no reason whatsoever, terminate this Agreement effective as of a date specified by such terminating Party in a written notice given to the non-terminating Party at least 30 days prior to such specified termination date.

4. DISPUTE RESOLUTION:

All disputes or differences arising out or in connection with the above will be settled amicably by both parties. This MOU is purely for academic usage.

5. TERMS AND CONDITIONS

This Memorandum shall commence from the date of its signing and shall continue for a period of 3 years from the date thereof and be automatically renewed for successive periods of 3 years unless either Party notifies in writing the other Party of its intention to terminate this MOU ninety days in advance. This Memorandum is not a legally binding contract and under no circumstances does this Memorandum subject either of the Parties to liability for breach, whether material or minor, of contract or any other liability under national or international law or any other applicable law. The Parties may nominate an identified individual to establish a "Joint Working Group" to manage and execute the cooperative activities mentioned in this MOU. Parties may use the other party's logo/branding only after prior permission from each other.
